## TERMS AND CONDITIONS

### Terms of payment for registration fees

- All participants must be registered
- At least one author of each registered paper must be registered for the conference.
- All payments must be made in Czech currency (CZK).
- Payments should be made online at time of registration (secure payment page).
- Registration will be valid only upon receipt of full payment received by email.
- The VAT (21%) is included in all registration fees.
- Payments by online bank transfer or by card transfer (VISA, MasterCard, GPay) are accepted.
- Online payments will be processed via a secure payment page PayU on the online registration system.
- If an invoice is required, the registration must contain complete data for its issue.

### Cancellation policy

- Before 1 July 2024: a 2.500 CZK cancellation fee will be applied
- After 1 July 2024: no refunds are applicable
